

RULES FOR ELECTION TO THE SACKVILLE SPORTS HERITAGE HALL OF FAME. REVISED – October 2018

- Authorization By authorization of the Board of Directors of the Sackville Sports
 Heritage Foundation, members in good standing of the Sackville Sports Heritage
 Foundation are authorized to hold an election (if there are eligible candidates) for the
 purpose of electing members to the Sackville Sports Hall of Fame.
- 2. Electors Only active members of the Sackville Sports Heritage Society shall vote.
- 3. Eligible Candidate Only those who have contributed to the development or enhancement of sport as athletes, coaches, officials, teams or builders, in Districts 14 and 15 (including Beaverbank and Lucasville) for a minimum period of four years will be considered. Local, provincial, national and international achievements will be considered. Volunteer work in the community will be considered an asset.
- 4. Special Guests may be invited to attend the induction ceremony.
- 5. Screening Committee shall consist of a minimum of 3 members approved by the Board of Directors. The committee may consist of board and non-board members on this committee shall not vote on the final selection which will be conducted by the Board of Directors. The duty of the Screening Committee shall be to prepare a ballot listing in alphabetical order of eligible candidates who:
 - a) Are eligible having been nominated by a group or individual.
 - **b)** Candidates shall remain on the ballot for a period of three (3) induction ceremonies and may reapply following three induction ceremonies.
- **6. Voting** shall be based on the individual's or group's career achievements and service to the Sackville Sports Community as per number 3.
- Certification of Election Results The results of the election shall be certified by the Board of Directors.
- **8. Notification –** The Board of Directors shall, through an appointed representative, notify the successful candidates within 10 days of the final tabulation of votes.
- **9. Amendments –** The Board of Directors of the Sackville Sports Heritage Foundation reserves the right to revoke, alter or amend any of these rules at anytime.
